### Background

The formation in 1997 of the Protective Coatings Technical Group (PCTG) of the Australasian Corrosion Association (ACA) coincided with two landmark dates in the history of the development of inorganic zinc coatings. It was exactly 60 years since the patent for the first inorganic zinc coating was taken out by its inventor, Victor Nightingall of Melbourne. Furthermore, it was exactly 50 years since his passing in 1947. The coinciding of these events made the celebration of this important Australian contribution to corrosion prevention an ideal inaugural activity of the PCTG.

The PCTG also ensured that Nightingall's final resting place would have some record of his contribution. A memorial plaque was cast and placed on his grave at Warringal cemetery in the Melbourne suburb of Heidelberg.

The current Coatings Technical Group aims to extend the achievements of previous members.
