### Corrosion & Prevention Paper Submissions and Presenting at Conference Terms & Conditions

By submitting a paper to the Australasian Corrosion Association (ACA) Corrosion & Prevention Conference you agree to the following terms and conditions:

#### 1. **Originality**

The paper must be an original work of the author(s) and must not have been published elsewhere or be under consideration for publication in any other journal or conference. The paper should not contain plagiarized content.

#### 2. **Author Eligibility**

The submitting author must be a registered participant of the conference. The paper should list all contributing authors, and each author must approve the final version of the submission.

#### 3. **Content Requirements**

The submitted paper should meet the conference's thematic and formatting requirements, as specified in the submission guidelines. Papers must be submitted in the required format (e.g., PDF, DOCX) and adhere to word count limits, citation styles, and other requirements as outlined.

#### 4. **Peer Review Process**

All submissions will undergo a peer review process. Authors will be notified of the review outcome, and the technical committee decisions will be final. Authors may be required to make revisions based on reviewer feedback.

#### 5. **Copyright and Licensing**

By submitting your paper, you grant ACA Corrosion & Prevention the right to publish the paper in the conference proceedings and/or on the conference website. Authors retain the copyright of the paper but agree to give ACA Corrosion & Prevention a non-exclusive, worldwide license to distribute and display the paper.

#### 6. **Conflicts of Interest**

Authors must disclose any potential conflicts of interest related to the submitted work. If a conflict of interest is discovered during the review process, the paper may be withdrawn.

#### 7. **Presentation Requirement**

If your paper is accepted, at least one author must register for the conference and present the paper in person at the event. Failure to present the paper may result in the exclusion of the paper from the conference proceedings.

Please note: Only one presenter is permitted per paper. Multiple presenters for the same paper are not allowed. The presenting author must be confirmed prior to the event and will be the only individual permitted to deliver the presentation onsite.

## 8. Revisions and Corrections

Authors may be asked to make corrections to the paper prior to publication. All revisions must be submitted by the specified deadline.

## 9. General Warranties

- 9.1 You warrant and agree that the information submitted in your application is true and correct in all respects.
- 9.2 You warrant and agree that your paper submission, presentation and all presentation materials will:
- (a) be ethically and honestly prepared and, if based on research or trials, that such research and trials were ethically and honestly conducted.
  - (b) not be defamatory or breach any person's rights of confidentiality, privacy, or other legal rights.
  - (c) not be misleading or deceptive in any respect; and/or.
  - (d) not have content that is offensive or that brings us, our members or the event into disrepute.
- 9.3 You agree that any presentation must be fairly based on, and consistent with, your paper submission or proposal to us, and with presentation materials you provide.
- 9.4 Authors must disclose any commercial interests or conflicts in regard to their paper subject
- 9.5 Authors and presenters must not use Aca conference to denigrate, defame or by any means impact on the reputation of an ACA member or other business. The ACA can then choose to reject any paper they believe does not meet this requirement and also halt any presentation at the conference.

## 10. Privacy and Data Protection

The personal data provided during the submission process will be handled in accordance with our [Privacy Policy](#). The data will be used for purposes related to the conference organisation and ACA communications. Subject to the provisions of this agreement, the parties agree to hold in confidence and refrain from disclosure to third parties confidential information of the other party and to take reasonable precautions to prevent third parties from gaining unauthorised access to it.
